Guest Speaker: Dr. Don Carter



Biography

Donald E. Carter, Ed. D., is the Superintendent of the Kern High School District. His 35-year career in education includes teaching, coaching and administrative experience. He has born and raised in Bakersfield, attended local schools and graduated from West High. He is active in the community, serving a

number of local organizations in a leadership capacity.

Dr. Carter began his career with the district in 1976 as a science and mathematics teacher at Bakersfield High. He chaired the school's Science Department from 1985 to 1989 when he began his administrative career as Dean of Students at East Bakersfield High. Ensuing administrative positions include Assistant Principal for Bakersfield High, District Director of Business Administration, Principal of Bakersfield High, and District Associate Superintendent for Instruction. He was named Superintendent in 2004.

Dr. Carter's educational experiences include coaching and officiating responsibilities. He was West High's tennis coach for 10 years. He also coached National Junior Basketball teams, served as Instructional Chairman for the Kern County Officials Association and co-founded the district's Physics Olympics program.

Dr. Carter's career is founded on educational degrees that include a Bachelor's in Mathematics and Physical Sciences from the University of Laverne, a Master's in Educational Management from California State University, Bakersfield and a Doctorate in Educational Leadership from the University of La Verne.

Dr. Carter's educational excellence has been acknowledged with a variety of awards and honors. He twice received Bakersfield High's Distinguished Faculty Member Award. He has been a presenter at a national convention for the National Science Teachers' Association and the state convention of the California Science Teachers' Association. He is much sought after by colleges, universities and other educational institutions. He is an instructor for the University of La Verne and Point Loma Nazarene University. He has also taught classes for Bakersfield Adult School and Bakersfield College.

Dr. Carter's commitment to the community includes service on the boards of such organizations as Fiscal Crisis & Management Assistance Team (FCMAT), Kern County Workforce Investment Board, Kern County Network for Children, Kern Science Foundation, and the KHSD Educational Foundation. In 1995, Dr. Carter served as Master of Ceremonies for the Bakersfield Prayer Breakfast. .

Dr. Carter's commitment to the community has also included involvement in such organizations as the Association of California School Administrators, Phi Delta Kappa, National Association of Secondary School Principals, the Jim Burke Educational Foundation's Educational Leaders Forum, Youth For Christ, Kern County Superintendent of Schools Administrative Advisory Council, California State University, Bakersfield Enrollment Advisory Committee and Point Loma Nazarene University Educator Advisory Committee.

Topic: Challenges and Successes In KHSD

Kern County students present the public schools they attend significant challenges including language, socioeconomic, mobility, and special education issues. Yet, the Kern High School District (KHSD) continues to provide a curriculum that meets the needs of its most challenged students while also meeting the needs of Kern County's most gifted students. Many in the latter group often begin pursuing a career in engineering while still in high school. The District's success in preparing students for postsecondary studies in engineering is reflected in those who annually receive the KHSD Superintendent's First In Class Awards. A high percentage of these students - honored for having the highest grade point average in their graduating class - are accepted to some of the nation's most respected engineering schools. The District's success is a credit to its teachers, parents and strong support from the community, particularly the oil industry.

TECHNICAL SESSION



Speaker: Linwood A. "Skip" Carleton, Jr., PLS

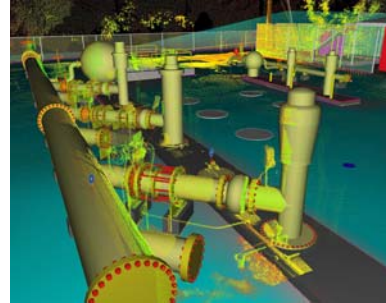
Skip is the Regional Survey Manager for Cannon. Based in Bakersfield, CA he oversees land surveying services for Cannon in the Central Valley and north Los Angeles County. Mr. Carleton started out in engineering but veered

into land surveying at an early age; he spent his first ten years swinging sledgehammers and machetes on survey field crews before moving into the professional ranks. Now a registered professional land surveyor in seven western states, he has managed projects from \$6,000 to \$6,000,000 in a wide variety of environments. Beginning in 2006 he began advocating 3D laser scanning and modeling as a tool

that would change the engineering community's approach to design. With its robust data capture and high precision, 3D scanning and modeling cannot be matched for facilities engineering design needs.

Topic: 3D Laser Scanning and its Application to Plant Retrofits

Recent advances in the hardware and software used to deliver design quality 3D models and CAD drawing files are significant. The newly released upgrades in hardware and software have enhanced both speed and accuracy. The ability to provide near real-time design



quality data for plant design and plant retrofitting with accuracies better than 4mm has eliminated the need for dependency on as-built drawings or more crude conventional field data acquisition. This technology now provides fast and accurate design quality data for complex, asymmetrically shaped and sometimes inaccessible structural features often found in plant environments. The resulting true 3D objects depicting the actual as-built conditions yields not only precise dimensioned drawings but provides a wealth of data routinely omitted by conventional data gathering methods as well as a permanent archive of the conditions. The ability for facility engineers and piping designers to virtually bring the plant site to their desktop via a precise 3D CAD model of the project is here. Unlike 2D plans and isometrics the 3D imagery's powerful visuals provide all viewers with an intuitive grasp of the facility's existing conditions. Thoughtful design and reliable interference checking can be performed at the desktop. The new fixtures can be designed, fabricated and installed with the foreknowledge of a good fit, avoiding change orders and schedule slips. Additionally the 3D CAD model lives on beyond the design phase, serving as a valuable asset enhancing facility management and operation.

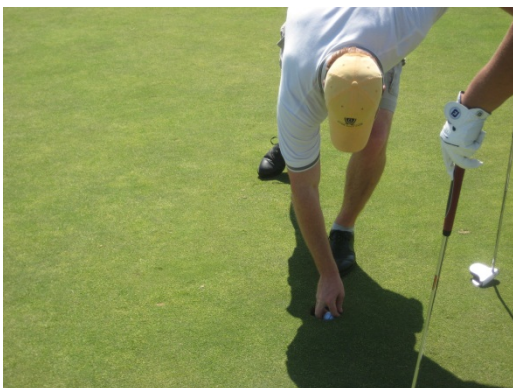

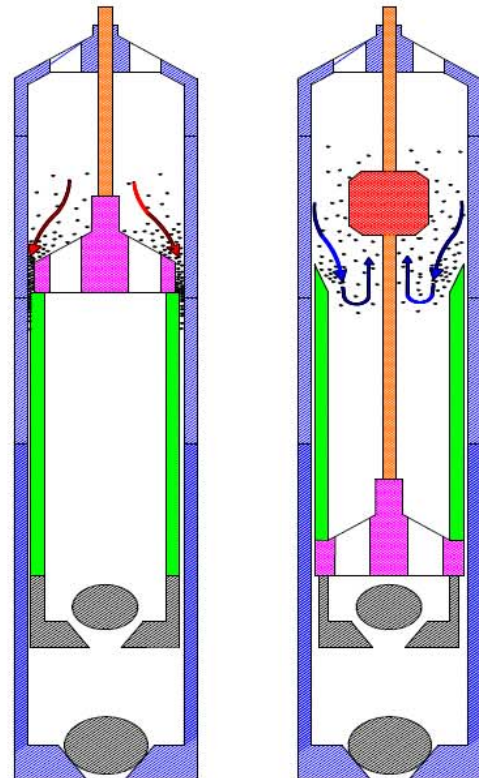
