## **“DOGGR’s UIC & Idle Well Regulatory Packages . ”**

DOGGR has new regulatory packages on the horizon that will require enhanced compliance efforts by California’s oil and gas operators. The new idle well regulations are intended to reduce the amount of idle and orphan wells that pose a liability to the State and operators. The regulations will require idle wells be tested and, if necessary, repaired, or plugged and abandoned. There are approximately 30,000 wells in California categorized as idle. The new Underground Injection Control (UIC) regulations are meant to replace outdated regulatory language with requirements that are specific to California’s unique operating environment. The new UIC regulations also address specific mechanical integrity testing intervals and requirements. Learn how the new regulations came about and what the next steps will be for operators to build compliance programs.

Mrs. Janel Kay Harris spent the last ten years working for California’s Division of Oil, Gas, and Geothermal Resources in the Los Angeles basin, Coalinga (yes, you read that right), coastal and offshore fields of California, and finally settled in Bakersfield. Janel has been a field engineer witnessing every kind of permitted field operations throughout the state. She has been a Well Site Manager for DOGGR during State sponsored orphan well abandonments. From 2015-2018, Janel was the Senior Oil & Gas Engineer, Supervisor that oversaw all permitting and UIC project reviews for oil fields located east of I-5 in Kern and Tulare County. In 2018, she took on the role of the DOGGR Training Officer to create a knowledgeable workforce and consistent state-wide instruction for all levels of DOGGR engineers. She is a licensed API-653 Aboveground Tank Inspector. She has a degree in Geology from San Francisco State University and is pursuing a Master’s of Science in Global Energy Management from the University of Colorado at Denver.

2. Letters of Recommendation: A minimum of two and a maximum of three recent letters. A school instructor who is familiar with your current academic accomplishments should submit at least one of these.
3. Academic Transcript: Must be on high school/college/university letterhead. Please submit current or most recent transcript showing courses taken and grades earned during the past two years.
4. Proof of Enrollment: Recipient must be enrolled as a full-time student (12 or more credit hours) at an accredited college or university. Proof of enrollment must be received prior to disbursement of scholarship funds but is not required at the time of submittal of the scholarship application.
5. Essay: Please submit a short essay of approximately 500 words for two essay questions and 200 words for the informational question that are found later in the application.
6. Email Documents: Applications will be required to be emailed to all committee members. Scan and attach all documents in .pdf format. Transcripts and letters of recommendations can be sent via U.S. Mail if needed. If it is necessary that you need to mail the application, we will accept it, but the preference is by email. For any hardships, please contact the Scholarship Committee Chair below.

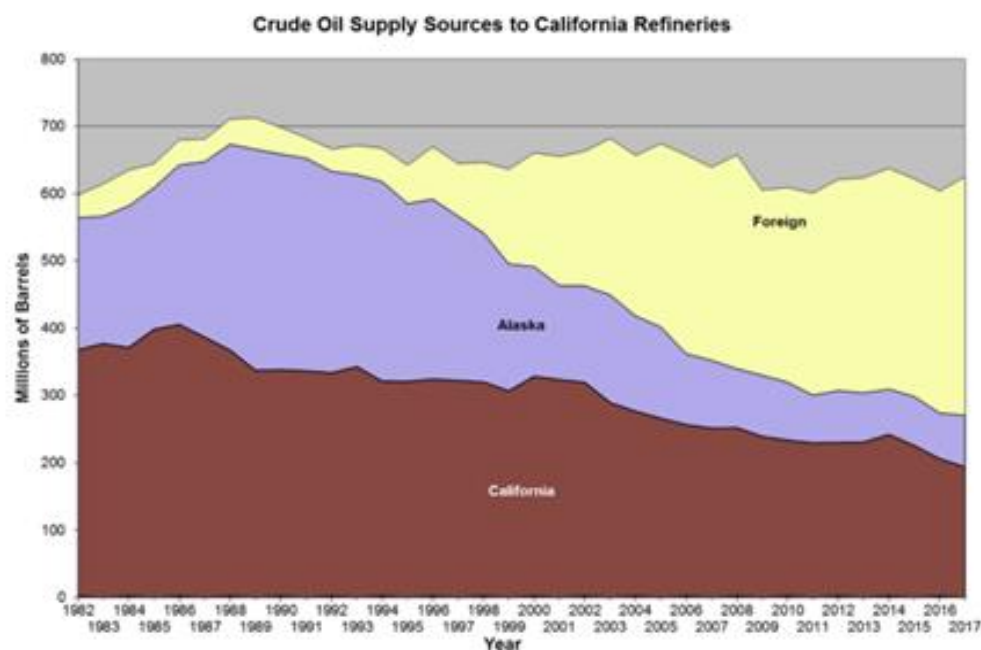

**Please answer any two of the three essay questions below. Each question should be answered in a short essay of approximately 500 words.**

### Essay Question # 1:

California is considered by many to be an energy island. No crude oil pipelines exist to ship crude into the state from the other lower 48 states yet nearly 70% of the crude oil consumed in the state is imported -mostly via oil tanker / sea from foreign sources. Should this be a concern for Californians? Why? What are the risks? What could be done to alleviate those risks?

Please refer to the graph above. The data has been supplied by the California Energy Commission, California's primary energy policy & planning agency. It is important to know that all of the crude oil supplied to CA is consumed only in CA.

Please write about the macro trends that you think are driving the data in the graph. Things to consider: 1) Crude oil supply / consumption is about the same 2017 as 1982. 2) Foreign sources of oil supply have increased drastically in the last 20 years. 3) California production is decreasing consistently since 1986 but that decline has steepened in the last five years.

**Essay Question # 3:**

In early 2018 oil prices were rebounding. At the same time production in the U.S. hit record highs, which contributed to an oversupply. A similar situation occurred worldwide as Saudi Arabia and Russia, two of the largest oil producing countries, also had record production, adding to a surplus of oil on the global markets. This oversupply is a major factor for the softening of prices.

What initiatives can be taken on a global scale to help stabilize production and crude oil prices?

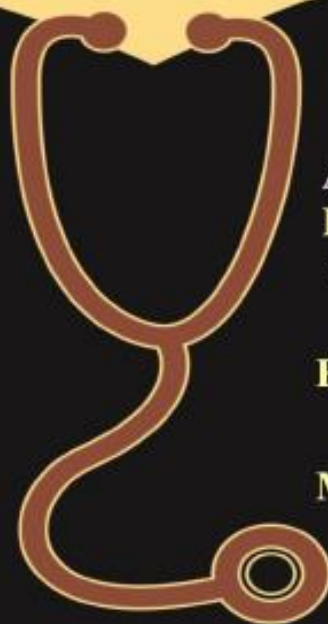

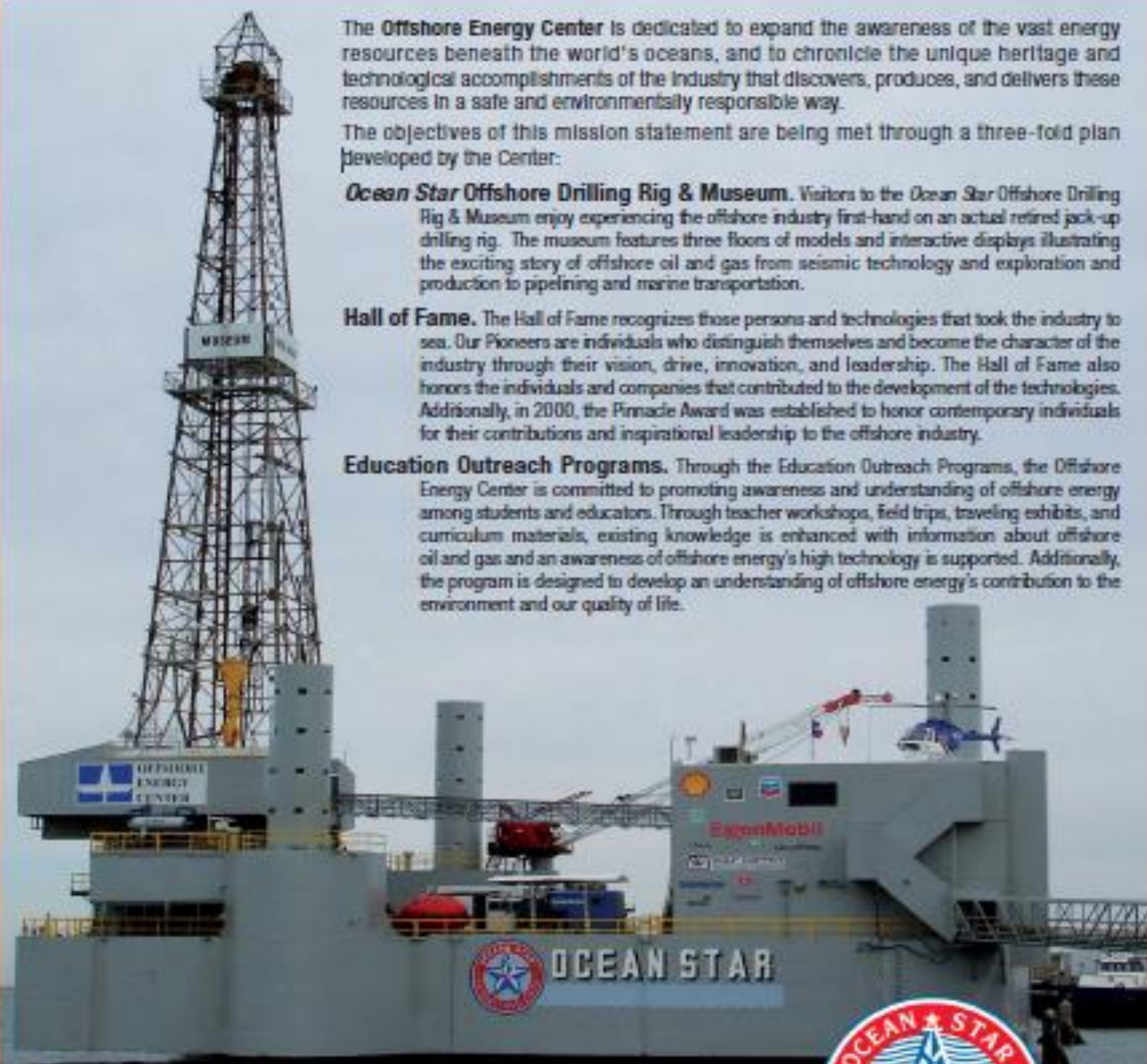

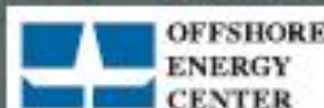
