## "Lessons learned in changing the story about our industry"

Christina Sistrunk is president and CEO of Aera Energy LLC, one of the largest California and U.S. oil producers with annual revenues of more than \$2 billion. Delivering 25 percent of the state's production, Aera is one of the nation's most active drillers, operating more than 14,500 wells aimed at powering great todays and better tomorrows.

Aera as a company holds many of the values of the State of California: it strives to innovate using lean manufacturing and other processes; celebrates the productivity of a culture of people who are passionately engaged and collectively empowered; and advocates for the preservation of the State and prosperity of its people.

Under Sistrunk's leadership, Aera will extend its environmental California's largest, and first-of-its-kind solar energy project to use

solar steam and solar electricity to power oilfield operations at Belridge oilfield. Sistrunk began her career with Amoco Production Company in Louisiana working in a variety of production, facilities and reservoir engineering assignments focused on Gulf of Mexico engineering and development. In 1998 she joined Shell and held a series of technical and management positions, including operations manager and asset manager in the Gulf of Mexico and a two-year assignment as health, safety and environment manager for the Americas.

Sistrunk had a global role for worldwide exploration and production based in Rijswijk, The Netherlands to lead the creation and implementation of process safety improvement programs. She returned to the U.S. in 2009 as vice president of production assets for the Gulf of Mexico and later became vice president of Arctic capability. In that role, Sistrunk led the development of technology, people and systems to enable responsible Arctic development.

With Aera's commitment to produce the oil that enables millions of Californians to travel to work every day, allows businesses to grow and thrive, and helps California-grown food to arrive at dinner tables, Sistrunk's personal commitment provides a link to make that happen. She serves on the governing board of the Kern County Hospital Authority; is a board member of the California Chamber of Commerce; and member and past chair of the Western States Petroleum Association Board of Directors. Sistrunk also serves on the executive committee and board of directors for the California Business Roundtable.

She is a valued thought partner in the G100 Network of chief executives driving candid conversations about leadership, strategy and navigating the current business environment; California Foundation on the Environment and the Economy (CFEE), bringing together leaders from across the sectors with elected and appointed leaders in forums concerning fundamental environmental and economic infrastructure issues in California; and the Executive Women in Energy Initiative, supporting women leaders in advancing to the top of their organizations to boost industry performance.

- 4. <u>Proof of Enrollment:</u> Recipient must be enrolled as a full-time student (12 or more credit hours) at an accredited college or university. Proof of enrollment must be received prior to disbursement of scholarship funds but is not required at the time of submittal of the scholarship application.
- Essay: Please submit a short essay of approximately <u>500 words for two essay</u> <u>questions</u> and <u>200 words for the informational question</u> that are found later in the application.
- 6. <u>Email Documents:</u> Applications will be required to be emailed to all committee members. Scan and attach all documents in .pdf format. Transcripts and letters of recommendations can be sent via U.S. Mail if needed. If it is necessary that you need to mail the application, we will accept it, but the preference is by email. For any hardships, please contact the Scholarship Committee Chair below.




Please answer any two of the three essay questions below. Each question should be answered in a short essay of approximately 500 words.

#### Essay Question #1:

California is considered by many to be an energy island. No crude oil pipelines exist to ship crude into the state from the other lower 48 states yet nearly 70% of the crude oil consumed in the state is imported -mostly via oil tanker / sea from foreign sources. Should this be a concern for Californians? Why? What are the risks? What could be done to alleviate those risks?

Please refer to the graph above. The data has been supplied by the California Energy Commission, California's primary energy policy & planning agency. It is important to know that all of the crude oil supplied to CA is consumed only in CA.

Please write about the macro trends that you think are driving the data in the graph. Things to consider: 1) Crude oil supply / consumption is about the same 2017 as 1982. 2) Foreign sources of oil supply have increased drastically in the last 20 years. 3) California production is decreasing consistently since 1986 but that decline has steepened in the last five years.

#### Essay Question #3:

In early 2018 oil prices were rebounding. At the same time production in the U.S. hit record highs, which contributed to an oversupply. A similar situation occurred worldwide as Saudi Arabia and Russia, two of the largest oil producing countries, also had record production, adding to a surplus of oil on the global markets. This oversupply is a major factor for the softening of prices.

What initiatives can be taken on a global scale to help stabilize production and crude oil prices?
